• Summary: The District of Delaware has consistently ranked as one of the top jurisdictions for patent infringement cases, but has only four authorized district judgeships (and now four full-time magistrate judges and one senior district judge). This has resulted in the Court having one of the highest weighted caseloads per judge amongst all U.S. District Courts. This panel features a conversation with, and insight from, those District of Delaware judges regarding the handling of their voluminous and time-consuming patent dockets, the utilization of the District of Delaware's experienced and adept magistrate judges, and the judges' views on new and complex patent-law issues that often find their first impression in Delaware.

10:15 AM - 11:15 AM Panel II: ANDA Litigation: A View from the Bench

Summary: ANDA litigation is unique from other patent litigation because it involves a
hypothetical injury, it requires a bench trial before the 30-month stay expires, there are often
multiple co-defendants who are not aligned (because they are competitors with each other),
and defendants behave like plaintiffs. The vast majority of ANDA cases in Delaware (65% of all
pending ANDA cases in 2023, 57% of newly filed ANDA cases in 2023). The 5 busiest judges for
ANDA cases are all Delaware judges.
