### **Patent Remedies and Damages**

The law defining the scope and calculation of available patent damages and injunctive remedies continues to evolve in courts, the ITC, and Congress. Panelists will discuss recent developments related to fact and expert evidence supporting royalty calculations (including apportionment and comparable license evidence) and the relevance of foreign commercialization in patent damages calculations after *WesternGeco* and *Brumfield*. **The Administrative State** – The administrative state is in flux.
